Summer Help – Received a couple applications. Hoping to receive a few more before we interview.

Comp Plan/Stantec – Assisting with model data, and gathering flow data for the hydrants.

**North Mason Fire Marshall** – Webb working with Jeremy Hicks to get unmonitored hydrants secured to help prevent theft of water.

Well Head Protection Plan/Pacific Groundwater Group – Webb reported that the District has entered an agreement with Pacific Groundwater Group and will assist in gathering data for the Comp Plan.

**Hwy 106/Alderwood Connection** – Bulls Eye Excavating made the tap and set the meter on the neighbor's property.

Fire Line Theler Center – Webb working with North Mason Fire to have engineers submit plans for the hydraulic model. Webb also working with Jay from Stantec on acceptable designs.

Morrison Connection - Webb is researching the situation and will advise Board of processes.

Romance Hill Pressure Tank Repair – Webb meeting with contractor to look at pressure tank and an estimate to repair.

**Hummingbird Road Maintenance Contribution** – Webb working with Matson and Hoeffer and proposing to the Board to contribute \$200 towards maintenance fun for the road. Webb trying to figure out correct way to make the contribution and be accountable to state auditor.

Budget Process/BIAS – Webb working with Chad at BIAS to produce budget; meeting scheduled with Chad to further discuss process Friday, June 15.

Job Descriptions/Salary Survey – Staff working on job descriptions. Once that is finalized, Webb will review with the Board.

**New Pension Contribution Rates** – State increased employee and employer contribution effective July 1, 2017. Webb proposing COLA increase to Board. Resolution will be presented to the Board on our next meeting, June 27, 2017.

Petty cash process – Resolution will be presented to the Board on our next meeting, June 27, 2017 requesting Webb and LaHaie to be able to sign checks for Petty Cash.

Mason County Signing Authority for Dale Webb – Resolution will be presented to the Board on our next meeting on June 27, 2017 authorizing Dale Webb to sign financial documents for Belfair Water District.
