**REGULAR MEETING OF MEMBERSHIP**

**North Mason School District Levy Election**

The Taxpayers for North Mason Schools presented a proposal in support of the upcoming school levy election to be held February 7, 2006 by mail-in ballot.

Debra Jacobs, co-chair of this committee had a great presentation that showed why we should support this levy.

Mike Boyle of the Taxpayers for North Mason and Tom Kelly, the school superintendent of the North Mason School District, gave the facts about the levy:

- The Levy supports 16% of the funds needed to run the schools.

- The current Levy expires on December 31, 2006.
- The levy runs for three years and is 16% of the budget each year: 2007 is \$2,863,000; 2008 is \$2,950,000; 2009 is \$3,038,500
- We are at the low range of assessments compared to other districts in the area.
- 3.5% of the fund balances are kept in-house and \$30,000 of the overages are going into the school bus fund and to buy “stuff “ not purchased on the budget last year.

This will be an all-mail-in ballot and they would like to pass it the first time. This requires 60% of the voters on the last general election voting to pass the levy.

### **Pacific Northwest Salmon Center**

Don Atkinson gave a presentation on the new plans for the Salmon Center. They are going to purchase 90 acres of the Jack Johnson property and he had a drawing of the proposed buildings, parking lots and breaching of the dike for a salmon channel to be built. They propose to redo the Theler Trails and make them better.

They are also designing ponds to collect runoff water from the Belfair area and filter it.

### ***Questions from the audience:***

What is the impact to the community and who pays for it?

They have \$25 million dedicated to the development and would be a responsible part of the local area.

Herb Gerhardt stated that the Salmon Center is controversial, but they have new directors and the meetings are now open to the public. He thinks we should give them a chance to present their case.

Bruce Landrum stated that the Salmon Center is a wonderful idea and needs accountabilities and responsibilities to the public for their \$25 million dollars of the taxpayers' money.

### **Health Care Forum Update**

Mike Greene presented the Health Care Forum idea and how it should work. The public's ideas for entry into the system and customer and patient needs were discussed.

The first Health Care Forum will be held on Saturday, February 4, 2006 at the Theler Community Center.

This will be an educational meeting and help create a plan for a health care delivery system.

Mr. Joel Hatfield will present a plan he has used in other areas.

***MOTION: Motion to adjourn by Bob Harris, second by Bruce Jackson and passed unanimously.***
